Trustees' Annual Report

Public Private Benefit

The objectives of the Group are as a unit of the Scout Association. The aim of the Scout Association is to promote the development of young people in achieving their full physical, intellectual, social and spiritual potentials, as individuals, as responsible citizens and as members of their local, national and international communities. The method of achieving the aim of the Association is by providing an enjoyable and attractive scheme of progressive training, based on the Scout Promise and Laws and guided by adult leadership.

Subscriptions are charged for membership to cover immediate running costs of the Group and these do not unduly restrict membership. The Group follows the principle that no one should be excluded because of their inability to pay membership subscriptions.

Two key principles demonstrate that Scouting's aims are for the public benefit are that through the Scout method young people develop towards their full potential and that there is a clear link between the benefits for young people and the purpose of Scouting. The safety of young people is taken very seriously and the benefits Scouting activities provide far outweigh the risks. Any private benefits from Scouting are incidental, other than to those as a beneficiary.

Chairman's Report

The year ending April 2023 saw a strong Scouting programme continue to be delivered, thankfully without the shackles of COVID.

Sadly, our GSL, David Shickle, resigned at the end of the year. Karl Nicholas, District Commissioner, is our de facto GSL until a replacement is in post.

The individual sections have continued their rich offering of activities and badges and the Group remains in good overall health. Individual section reports follow.

Camps, competitions, outings and sleepovers all returned with Spring Bank Camp, Summer Camp and Water Weekend able to take place once again and well attended.

The Group's finances remain on a sound basis despite limited fundraising activities: we were however able to run our Community Christmas Post which is part of Group's commitment to our local community.

Our two minibuses have been used well through the year and in spite of the associated expense provide us with programme opportunities that would otherwise not be possible.

As ever, all we achieve is only possible as a result of our fantastic volunteers who give up their time either to act as leaders/supporters of sections/activities or in support of administration, finance, etc, all of whom I thank.



Independent Examiner's Report to the Trustees

I report on the accounts of the Group for the year ended 31 March 2023, which are set out on pages 7 & 8.

Respective responsibilities of trustees and examiner

The Group's trustees are responsible for the preparation of the accounts. They consider that an audit is not required for this year (under section 43(2) of the Charities Act 1993, and that an independent examination is required.

It is my responsibility to:

- Examine the accounts (under section 43 (3)(a) of the 1993 act;
- To follow the procedures laid down in the general directions given by the Charity Commissioners under section 43 (7)(b) of the 1993 act; and
- To state whether particular matters have come to my attention.

Basis of independent examiner's report

My examination was carried out in accordance with the General Directions given by the Charity Commissioners. An examination includes a review of the accounting records kept by the Group and a comparison of the accounts presented with those records. It also included consideration of any unusual items or disclosures in the accounts, and seeking explanations from you as trustees concerning such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given in the accounts.

Major Activities and Achievements in the year

The annual review presented to all parents and interested parties prior to the AGM highlights the activities and achievements during the year. This is a comprehensive document that details numbers of young people in each section, a report from each section, abbreviated accounts and a review of the year.

At the end of the year the income reserves amounted to £549,650 (2022: £549,650). The Group's policy on reserves is to hold an amount that will enable it to replace the motor vehicles. The New HQ has been recorded as an asset within the accounts.

The trustees have identified the major risks to which they believe the Group is exposed. They have reviewed these and established systems to mitigate them.

As well as all that we once again worked in the community to litter pick around Epsom. Summer camp took us into the well-earned summer break, the Cubs had a brilliant time trying a whole range of new activities and this really helped build a sense of camaraderie amongst the three packs, something that we had been working on and intended to build on as we then moved into the Autumn term. Once again, the Leaders pulled together a great program for the term which we ran across all three packs again.



Our Autumn program included working towards the fire safety badge which saw the cubs get the opportunity to visit Epsom Fire Station, the much loved chip shop challenge which introduced the Cubs to the 'what3words' app to help them navigate around the best chip serving establishments that Epsom has to offer, night hikes, learning basic first aid to achieve the emergency first aid stage 1 badge, having fun with two nights of experiments to earn the Science badge and



just before the Christmas break we welcomed back our friends from Leatherhead Rifle Club who led a brilliant night of air rifle shooting which the Cubs all approached brilliantly. We also took part in the district challenge hike for the first time in a number of years. These camps cannot happen without the dedication and hard work of a team of Leaders and parent helpers, who give up their time to ensure that the Scouts have fun, learn a lot, and get introduced to a great outdoors camping experience. Each camp has a Camp Leader, and the hours that go into planning a well-run and organised camp is immense, and we need to thank every one of those Leaders and continue to support them in the future.

I wrote in our various newsletters about the activities that took place across the year, so I don't intend to repeat that here as they are still <u>available on our website</u>. Our vision in Scouts is that each young person can complete the Chief Scout Gold Award during the four years that they will be with us. This will require near enough 100% attendance as well as

extra work outside of general scout meetings, as well as attending most of the camps. Over the last three years with lockdowns and restrictions on inside meetings, this will unfortunately not be achievable by the majority of our current mid-age scouts. However, we do our best to plan this into the programme so that a scout will receive a Challenge Award each term, and one activity badge. This is becoming increasingly difficult with the number of leaders that we have and will certainly not be easy unless we get more leaders involved. We also want to ensure that we are getting the balance right between ticking badges off, and letting the scouts have fun and are outside as much as possible.

Recently, I attended a District event which laid out the core scouting skills that every youngster from Beaver to Explorer should engage in during their scouting journey. These are camping, navigation, bushcraft, hiking, health, pioneering, leadership, first-aid, values, and World. These core scouting skills will be taken into consideration when planning the programme next year, even if they don't always equate to badges.

Autumn term: 20 Explorers managed to get themselves a coveted place at Water Weekend after a mad dash for places and it looked like they had a blast. The rest of the term's activities included: favourites such as newspaper fashion show, ice skating and our very own Christmas Lights version of London Monopoly. A big group of Explorers (and parents) helped out at the annual Epsom Fireworks, and we were given a donation from the organisers that provided enough funds for a trip to Wisley to see festive light show, Glow. We headed off into the Christmas break feeling festive after our annual Explorer Christmas Dinner at the Epsom Club and our Friday night Christmas party of silly games which was topped off with some delicious cakes made by Explorer Daniel.

Spring term was helped out by the terrific programme ideas from our Explorer Jane – we held a games night, a World evening, Apprentice's Den, alongside more 'Scouty' activities such as a Town Trail, a maps evening and we debated religion with help from the Lead Minister, Catherine. Jane Barden came up from Scouts and ran a British Sign language evening for us – which taught us awareness as well as some basic signs – thanks Jane. Two brave souls entered the District Swim Gala but we couldn't rustle up any interest for the District Hike. 16 Explorers ventured to Dartmoor for the annual Easter Ex (pedition) over the Easter Weekend, where they hiked and mountain biked for four days, coming back tired but happy and full of memories.

In March, we sent two teams up to London to play in the National Scout Monopoly Run. They play a real-time version of the popular board game together with other challenges such as get your team to hug a tree or find an extra-large post-box as quickly as possible. Out of 1,386 teams, one team came top of their game and 9^{th} in overall position whilst the other came 4^{th} in their game and 654^{th} – in the top half of the teams. One of the Explorers said, 'It was a fun and exciting day, one of the great events on the scouting calendar'.

Explorer numbers have remained at a steady 30, losing a few to the advanced age of 18 and gaining a few from our Scouts alongside several Guides from the local groups. The leadership team alongside me remains the same – Dav, Rich, Dafydd, Aaron and Tom. We all have our strengths, and we carry on working together to make the young people's time at Explorers that of learning skills for life as well as making friends, working as a team and having fun. I can promise you it is quite a task to run an evening that keeps a group of 30 teenagers entertained. We seem to get it right more often than not! I can't thank the team enough for their help, support and more importantly, the camaraderie and laughs that come with it!!
